Sealed proposals will be received by the undersigned at the City of Mill Creek, 15728 Main Street, Mill Creek, Washington 98012, up to 2:30 p.m. local time on Thursday April 2, 2026, for furnishing the necessary labor, materials, equipment, tools, and guarantees thereof to construct Sweetwater Ranch Stormwater Main Replacement Project.

Work to be performed includes but is not limited to: the demolition and abandonment of the existing failing stormwater main, installation of new stormwater main through a wetland, and property restoration on the 1300 block of 144th Street SE in Mill Creek, WA.

The work shall be physically complete within 60 working days after the commencement date stated in the Notice to proceed. All bidding and construction are to be performed in compliance with the Contract Provisions for this project and any addenda issued thereto that are on file at the office of the City Clerk, City Hall, 15728 Main Street, Mill Creek, Washington 98012.

The Proposals will be publicly opened and read aloud shortly after the time and date stated above. Proposals are to be submitted only on the form provided with the Contract Provisions. All Proposals must be accompanied by a certified check, cashier's check, money order, or bid bond payable to the "City of Mill Creek" and in an amount of not less than five percent (5%) of the total amount bid.
